I would like to see our Fair Family come together while we're still on the Land and have an educational/spiritual low-impact renewal.





The Badge of Lost Innocence
Dear Fair Family News:

The OCF and its government are two separate entities. It is foolish to view them as one due to their intertwining.

The Fair itself has a different origin and goal than the Fair's government does. The Fair is born of our happiness, positively uniting our affections. The Fair's government is born of a negative need to restrain our vices. One encourages intercourse, the other creates distinctions. One is a patron; the other a punisher.

A time came in OCF history when the need for government arose. We began to require security crews, board of directors, etc. "Government, like dress," said Thomas Paine, "is the badge of lost innocence."

The dilemma arises when we are exposed to the same miseries <u>BY</u> a government as we might expect <u>WITHOUT</u> a government. Because then we are furnishing the very means by which we suffer.

Since security is the goal of government, its form should give us the least expense and the greatest benefit possible. OCF is at a stage of political experimentation currently. We are playing with a microcosm of the macrocosm.

Political apathy is as rampant at OCF as it is in the "real world" and the consquences are the same. Democracies turninto representative republics when the majority of members are inactive politically. Maybe we can gain an apprecation for the intense complexities at hand in the big, wide "real world" by attempting to tackle our little OCF problems.

I fear that involuting is not preferable to responsible expansion yet watch our latest population experiments with interest. How can we "save the world" and "fire the government" if we can't even run a hippie fair? Still, applaud our political attempts and hope that practice makes perfect for our governmental future. "Don't think it won't happen just because it hasn't happened yet."

FairFamilyForum:

A Call for a Vote Dear OCF Members:

Today (5/3/93) I submitted a petition, signed by more than 25 OCF participants, to the OCF Secretary to call a special meeting of its membershp to vote on whether or not the OCF administration will be allowed to subject the membership to any form of non-removable identification at this year's OCF. (Editor's Note: John submitted a second petition that had a sufficient number of member signatures.)

The "wristband" issue is one of those issues that is so important, it should be put before the full OCF membership for a proper vote. Please watch for notice of the special meeting of the membership, talk about the issue with other members, and come to the meeting to vote on the issue. As it now stands, unless we

vote "no!" on the issue at the special meeting, we will all have to physically submit to banding and comply with the new banding rules at this year's event.

Supporters of "banding" will tell you that there is no workable alternative to limit our nighttime population, and that there has been plenty of opportunity for dialogue on the issue.

The reality is that the powers-that-be could have placed the issue before the membership at last year's annual meeting, but the representatives of this membership organization know that if the membership is given any effective opportunity to vote on the issue, the vote will be a resounding "no!"

The idea of "banding" is based on mistrust. The politics of the OCF (as opposed to the event itself) has historically reflected the politics of the U.S.—a microcosm of the larger world rather than a real alternative. In the larger world we can see the negative thinking that has brought us to "banding" reflected in the "war on drugs" in the 1980's a vast turning up the heat with stiffer penalties, civil forfeitures, consequent ruined lives (Continued on page 10)

Wristbands: A Board Member's Perspective

The Oregon Country Fair is successful in many ways and in many things. Some have said that we are too successful in bringing both the general public to the Fair and people who "sneak" in.

Since I have been involved in the Fair, for almost 20 years, those who have come to the Fair have been distinguished and identified by some artificial means so that the Fair family can determine whether they should be on the land or not.

We charge the members of the public and give them tickets. We give staff T-shirts which have always allowed them to be on the property after hours. We give others, whether they be entertainers, booth people, or some other groups or individuals who belong on the property after hours, camping passes.

In a different world maybe the Fair should be free and everyone should be allowed to attend whenever they want. The Board over the past two years has heard the complaints of many as to the overpopulation problem both when the gates are open and when they are closed. Not everyone views this as a problem. It appears, however, that a substantial majority of the Fair family does. The Board has solicited solutions to this problem.

This Board has tried to debate openly these ideas and help and support operations when different solutions have been presented. Come on, folks,


get a grip.



and broken dreams—and no success at stemming the perceived drug "problem."

If we go at our common problems together, we can make staff shirts and camping passes work. Non-removable wristbands are just as counterfeitable as our current methods of identification, but much more subject to abuse by our representatives in authority. Members of the OCF shouldn't have to attend all the OCF meetings throughout the year to protect themselves from their own "representatives."

Please start saying "no!" to wristbands and vote "no!" to banding at the coming meeting.

Members and Meetings

Norma Sax, Secretary

Because there have been at least two petitions circulated recently within the Fair family, I thought it would be helpful to clarify just what the bylaws say about special meetings and petitions so that future petitions will not have to be invalidated because of a lack of enough member signatures or an incorrect request on the petition.

ARTICLE V: MEMBERS

1. <u>Membership</u>. There shall be one class of membership.

2. Eligibility and Admission. Any individual who subscribes to the purposes and basic policies of the corporation, who is registered with the corporation, and who has participated in one of the two previous years' Fair as volunteer, worker, performer, or booth participant may be deemed a member provided they abide by the terms and conditions of these bylaws, Articles of Incorporation and any amendments thereto, and act in accordance with the decisions made by the Board of Directors.

- (a) there is no membership fee required for general members
- (b) it is the responsibility of each member to register with the corporation...

6. Rights of Membership.

(a) Voting: All members who have been members for at least 30 days prior to the date of a membership meeting shall be entitled to cast one vote, in person or by mail, on any issue brought before the membership. Members shall vote to elect the Board of Di-

rectors, recall a director, amend the Articles of Incorporation, as provided by the Oregon Revised Statutes and by these bylaws. The Board of Directors shall make provisions for absentee balloting.

ARTICLE VI: MEMBER-SHIP MEETINGS

2. Special Meetings

Special meetings may be called from time to time by the Board of Directors and shall be called by the Secretary upon petition of 25 or more members of the corporation. In the case of a special meeting, notice shall be required as set forth in (3) below. The business of the special meetings shall be limited to those matters set forth in the notice.

3. Notice


Written notice of membership meetings shall be delivered by hand or by mail to all members currently registered in the records of the corporation not less than seven nor more than sixty days before the date set for the meeting. It shall be the responsibility of the member to provide the Secretary with a correct mailing address and any change thereof and failure to do so shall terminate the member's right to receive notice. In lieu of personally delivering the written notice, notice may be published in periodicals of general circulation (in) the greater community for at least two issues in a manner reasonably calculated to give membership in Oregon notice of such meeting.

4. Quorum. Two hundred members present at any duly called meeting shall constitute a quorum, except that at the annual meeting, those members present shall constitute a quorum.

5. Voting. All members are voting members. Except as otherwise provided in these bylaws, all members present at meeetings shall be entitled to vote and the Board of Directors may make provisions for absentee balloting from time to time as is appropriate. There shall be no proxies and no cumulative voting. Except as otherwise set forth in these bylaws, the majority of votes cast shall be required for the adoption of any matter coming before the membership.

As to the first, those interested in having us hang Nirvana Tubes in your booth, leave a message on my phone (602) 622-6245.


As to the second, I pray that we, the Fair FAmily, can approach this gathering in a spirit of One-ness. Yes, it's a

Feast of Change—Part two

There are 250 craft and food booths displaying the equivalent of several large shopping malls worth of toys, tasty treats, and useful items, all natural or hand made. The best of the booths have been constructed slowly, and modified over time—marvels in the tradition of nomad architecture. These spaces are precious, tended by many of the same folks and their children and kin for years, folks who, incidently, now have more customers than they ever imagined.

From Native American bark berry picking baskets to barbeque, from yurts to desserts, the Fair is a grand market event as well as a dionysian carnival. For relaxation one can get massages, take solar heated showers, join a drumming circle, or sweat in a large sauna (which some claim is the event's most profitable venture).

After the crowds of the day-20,000 people!-leave, the evening party begins, gently as the sun sets and building momentum around midnight. Several thousand happy campers turn on their lanterns, begin to unwind, share some food, and choose between the drumming, the dancing, the sauna, or hanging out with old friends. Nighttime policing—the "Sweep", an old Fair cat and mouse game—also commences. Uninvited guests to Saturday night's candlelight bacchanal have at times numbered over 5,000. Pity these poor security guards—and there are hundreds-who must miss out on the celebra-

The 1992 season is the first in which the Oregon Country Fair corporation, administator of the event, will not be obliged to use the sizable surplus the Fair generates for mortgage payments. The Fair, required to dispurse its income as a nonprofit educational entity, has over the past few years begun imagining creative and democratic ways of satisfying the myriad of desires which its material success has thrust upon it. Pressured to focus seriously on the future, working

committees have been pressed to come up with plans, especially for largescale site improvements and an endowment fund which would over the years sponsor those groups and movements the Fair collectively endorses. This process has not always been simple, since from time immemorial the psychic energythe vibes which sustain the the magic— have been directed either toward next summer's blast-the poster, the music, the passes— or in reminiscing over those earlier, better parties.

In spite of itself, perhaps, the success of the Fair has brought about a change in the way that certain things are done, although it is not always

two, the party in the woods and fields by the Long Tom river was on with no, or very low, "donations" for entry.

About ten years ago, after years of leasing its Veneta site, the Fair board, guided by the foresight and determination of Ron Chase, made the momentous decision to take, out a mortgage and purchase the property outright for \$250,000. Part of this was paid up front, with about 60% left to pay. This obviously meant a much larger commitment to long range planning and to financial accountability than some had previously imagined or desired. People in positions of responsibility would now need to make sure that books were kept in order and receipts

easy to discern the dynamics of this transformation. In the first place, to put together a history of this venerable yet generally undocumented instituion, one needs to trust faulty memory and much hearsay. Many of the folks who did the most to get things underway now reside in other regions, and those who remain and have been members of the family for years are not necessarily willing to say much, preserving in their way the event's mystique. One of the oldest timers I spoke with struggled to find words which expressed the nature of the changes in the way the Fair works, but could only come up with: "It's different, man, it is sooooo different." As if his tone could explain it all (which of course, it did).

Long ago, it is said, legal permits for the Fair might not arrive until a few days before it was scheduled to happen. When the county finally obliged, once again, that the Fair could procede, word would be spread through networks of friends. In a day or

would add up correctly. Lines of accountability would need to be drawn on paper, not in the imagination.

It is said that almost the entire board quit after the bravado of making this fateful decision. This tumultuous situation led in the early eighties to the creation of the position of general manager, first voluntary and then in 1989 the OCF's first paid staff position.

Recall the moral lesson of the Cat in Hat: Pick up after your "things" if you have a big party. At this level, the Fair is an international showcase of recycling: the most resource conscious event of its size in the world. But this leaves unaswered a trickier question: when the cat is away, who organizes the play (and the maintenance?)

Perhaps if there is anything truly magic about the Fair, it lies in its ability to keep the questions of responsible selfgovernment open and fluid while still managing to "take care of business." The ad hoc parameters within which the board, the manager, the committees, the vendors, the local community, and the "Fair family" operate retain a certain spirit of openness and confidence. This is important to keep in mind as we witness the Fair begin one of its decennial molting processes.

From the perspective of the State, the Fair is a nonprofit educational corporation with the bottom line of decisionmaking held by its "members": all those with some affiliation with any aspect of the event. This group meets in the autumn of each year at the WOW Hall in Eugene to select a ten person board of directors who serve staggered terms of 2 years. The Board prepares general proposals, while convening committees and overseeing the small paid staff of three and the huge team of volunteers. These volunteers, the muscle and lifeblood of the Fair, are divided into large crews: recycling, traffic, communications, bubbles.

Patient and intelligent planning has gone into the generation of an endowment fund which would grant small awards to groups in the Northwest (Pacific Cascadia) that uphold the Fair's (carnivalesque) vision. The tentative categories for consideration are ecological, agriculture, and theater groups. Although there are plans to distribute some money in 1993, it will take several years for the interest bearing principle to accrue to a significant amount.)

With all this in mind, the OCF now is at a cusp. With over two decades of generally great success, it has made lots of folks quite happy. The list of people to thank for this would fill up an article longer than the one already written.

This little gathering in the woods—our feast of time, of becoming, change, renewal has moved toward the millenium without loosing its original flavor and with very few compromises with the "straight", anti-festive world of normality. In its best moments it has kept the utopian sense of the 60's alive without becoming mired in nostalgia and packaged emotions. Now able to sponsor groups and persons doing Fair work every day, the Oregon Country Fair is chrystalising into something new and potentially wondrous.



Under the background section of the budget discussion, the decrease is \$6,000. Watch out for those zeroes. Although they are a pretty good band.

Vote: The motion passed 10 for, 0 opposed.

REPORTS

General Manager

Leslie Scott, General Manager, said we had a lovely Spring Fling, one of the highlights of which was a video of the '92 Fair produced by our Video Coordinator, Rock Badger. (And the secretary stole the office copy this morning so she could watch it while she does the minutes. can sax write and watch at the same time? you be the judge. oh, there goes...oh, sorry the parade just went by.) Leslie thanked Camille Cole and Norma Sax for organizing the event and David Paul for his entertainer expertise.

Leslie also reported that we had a wonderful turnout for our first "let's show off for the neighbors" open house. We invited about 100 Veneta/Elmira neighbors for a walk around the site and about 75 came for a beautiful Sunday stroll. Thanks to Patti Lamont and Beth Little for organizing the event, Bill and the Vegmanecs (sounds like a garage band) for making the joint look so spiffy and safe, Sue Kesey for the tasty ice cream, Cory Sullivan for arranging the entertainment. And here's to the goddess of sunshine for the brightest, warmest day we've had in these parts in quite a long, strange spell. The neighbors had such a good time (and so did we) they asked us to do it again.

An emergency response drill is scheduled for Tuesday, July 6 at the Fair site. Everyone is urged to participate, particularly coordinators and crew leaders. Robert Aurnague DeSpain and Palmer Parker will be coordinating it.

The first draft of the operations manual is almost complete. Leslie is hoping to have it finished by the Fair. Site Manager

Bill Verner, Site Manager, thanked the volunteers who helped turn all the fallen tree limbs into a nice pile of chips. And dips. And salsa. Sour cream, avocados. (Oh, sorry, there was a burrito booth in the video.)

So, Bill what else is new? There are lots of mosquitoes at the site, "a sign of a healthy ecosystem," we are told.

Bill expressed his appreciation to the Vegmanecs for their stewardship of the land. Each Vegmanec adopted an area of responsibility, to seed, mow and do whatever is needed. Bill, with no prompting from anyone, thanked everyone from his heart for the yurt. He's a happy not-camper. <u>Treasurer</u>

Hilary Anthony, (hmm, we have Bill and Hilary in this organization—are we following a trend?), said we are moving from the season of budget to the season of cash management. She and Leslie are getting the office ready to accommodate the flood of receipts and checks coming in and going out, respectively. The CD's that were deposited after last year's Fair have matured. One of them is now liquid and the others are to be spent for start-up expenses. Two of the CDs are reinvested, including the endowment which now has \$30,468.

Hilary presented the Board with a cash report and proposed that the Fair budget year go from May 1 to May 1. Last year Nance Sledge made cash projections to cover this transition period and Hilary included the remaining significant balance on the current cash report. Hilary is going to write to coordinators, clarifying the reimbursement process and explaining how to spend their budget, how to get paid back for expenditures, how to get that receipt from the vendor to the Fair office.

Hilary will continue Nance's practice of regularly giving a printout to coordinators of their budget compared to how much money had been spent to date. the budget committee would like feedback from coordinators on how and why their budgets are over or under.

NEW BUSINESS (PART ONE)

A Gathering of Nations

Several organizers of the First Annual Spiritual Gathering and Gathering of the Nations '93 asked the OCF Board of Directors to consider allowing the Gathering to be held on the Fair site in late July or early September.

The organizers write "The Spiritual Gathering and Gathering of the Nations '93, is conceived in the spirit of potlatch. This is the cultural teaching of sharing and giving which was embodied in the native way of life on this continent for many, many centuries, and is kept alive today within the culture. This gathering is intended as an encampment of Native People for the purpose of celebration, ceremony and thanksgiving. The encampment is designed as a sharing of culture for the purpose of awakening, remembering and education. Through the sharing of traditional foods, crafts, laughter, song and dance the gathering will provide an educational experience that will promote understanding and unity among native and non-native people."

The Gathering was rained out from its original time and place of May in Coburg. The process for securing a mass gathering permit is in the works. The Gathering would be held in the Fair parking lot area. About 40,000 people are expected to attend the event; there would be 2-3,00 campers.

Board members asked the organizers to provide them with information on the organization of the event and insurance options prior to the next Board meeting, where they will vote on the proposal.

CAPITAL PROJECTS BUDGET

<u>Motion:</u> Anne moved to approve the Capital Projects Budget as presented by the Budget Committee., with an additional \$1,000 for yew poles. Margo seconded.

Background: The total capital projects budget recommended by the Budget Committee is \$28,175, including \$13,320 for projects carried over from 1992. Proposed 1993 expenditures are: Move Circus \$5,700; Widen Bus Road \$8,800; Reefer Bridge II \$2,500; Main Camp Kitchen \$2,500; 500 Yew Poles \$1500; New Gates \$500; Fencing \$1,500; Traffic Shed \$600; Community Village \$500; Community Village \$500; Community Village \$350; Tractor Frontloader \$1,200; Recycling \$225; Yurt Repair (Main Camp) \$2,000.

The Budget Committee is recommending the Fair make a \$15,000 payment on the yurt, paying \$7,500 right away and paying the other half in November when it is scheduled.

<u>Public Discussion</u>: John Higby of Community Village explained the Village's plans to rebuild several of its booths. The CV asked for \$3500; the Budget Committee approved only







\$500. The Village, which is concerned about making safe booths, has set aside \$700 from their general budget to work on these booths.

Leslie said part of the difficulty for the Budget committee regarding the CV was that the Village has its own bank account and the BC does not have enough information on how the Village handles its finances.

dahinda meda said there is a resource for acquiring yew logs at a great discount now and urged the Board to consider another sum included in the budget for purchasing as many yew poles as possible.

<u>Board Discussion</u>: Jack said \$500 is not a realistic sum for the Community Village, even if they have to do minor repairs. He also said if we don't take advantage of the yew poles deal, we'll be sorry.

Paxton asked about the Village's ability to complete construction since there is no construction coordinator. John Higbe assured the Board the CV will complete the project.

Anne feels if the construction amount for the Village is increased, she would like to see the Village work with the Fair in making these booths as safe as possible.

Steve G. would also like to see the relationship with the Community Village clarified.

Amendment: Paxton moved to add \$1500 to the Community Village Reconstruction Project. This money will be accounted for separately from the Community Village funds and will be used only for 1993 booth construction materials. Any amounts left over after the 1993 Fair will revert to the OCF General Fund. Bob seconded.

<u>Vote on Amendment</u>: The amendment passed 8 for, 2 opposed (Jeanne and Margo).

Vote on Motion: The motion passed, 10 for, 0 opposed.

BUDGET REVISITED

<u>Motion:</u> Steve G. moved to amend and approve as amended the 1993 operating budget with \$1,000 added in the General Manager budget as a contingency for Trotter's Road. Paxton seconded.

Background: Items changed in the budget are: Community Village (from \$3,130 to \$3,430); History Booth (from \$13,908 to \$14,478); Medical (\$6,000 to \$6,500); Office in Town (from \$14,600 to \$15,800); Teens (\$3,425 to \$4,425); Water (from \$1,893 to \$3,293), General Manager (increase by \$1,500).

Vote: The motion passed, 10 for, 0 opposed.

BUMS

Motion: Margo moved to appoint Andrew Harvey, Sallie Edmunds, and Robert Aurnague DeSpain as Back Up Managers for the 1993 Fair. Steve G. seconded.

Vote: The motion passed, 9 for, 1 (Bob) opposed.

TRAFFIC CO-COORDINATORS

Motion: Steve W. moved the Board name Steve Gorham and Dean Grasseth as Traffic Co-coordinators. Jim seconded.

Background: Steve and Dean would serve with JR Robinson, Don Tada, and Steve Wisnovsky as Traffic co-coordinators. They would really like to have Erica Robinson too, but Erica said no way, Jose, so there we are. However, we all know Erica works like a sun of a gun (or daughter of a gun as the case may be) to keep these guys in line and they couldn't make it without her.

<u>Vote</u>: The motion passed, 9 for, 0 opposed, 1 (Steve G.) abstained.

LOGO RESULTS

<u>Motion</u>: Anne moved to accept five logo items for sale. Jeanne seconded.

<u>Background</u>: Board members voted on which logo items submitted by craftspeople will be allowed to be sold at the 1993 Fair. The top five vote getters were a silver pendant, a pottery mug, a cotton bandana, a cotton book bag, and an etched glass mug.

<u>Vote</u>: The motion passed, 8 for, 1 opposed (Paxton), 1 abstained (Bob).

WRISTBANDS

Resolution: The Board encourages the Secretary to set a

meeting to discuss wristbands, as per a petition asking for such a meeting, no later than June 7.

Background: The Secretary was presented with a petition stating "We, the undersigned members of the Oregon Country Fair, do hereby petition the Secretary of the OCF, according to Article VI, sections 2 and 3 of the OCF bylaws, to call a special meeting of the OCF members as soon as possible (and prior to this year's Fair) for the sole purpose of allowing the membership of the OCF at that meeting to affirm or deny by a membership vote, the previously asserted right of the OCF Board of Directors to order that all OCF—approved campers at this year's event shall submit to a wristband form (or any form) of non-removable official identification. The board, made up of elected representatives of the OCF membership, shall be bound to abide by the vote of the membership at this special meeting."

If the Secretary verifies that 25 members have signed the petition, she will then call a special meeting.

<u>Board Discussion</u>: Paxton would like to see the issue on the October ballot. Jack does not want to unduly influence or manipulate the Secretary (who, it should be noted, is open to bribes of a chocolate persuasion).

Other Board members would like us to abide by the by-laws and if the petition is validated, go ahead with the meeting as soon as possible.

<u>Vote on Resolution</u>: The resolution passed, 8 for, 2 opposed (Paxton and Jack).

NEW BUSINESS, PART TWO

RAPE AWARENESS AND PREVENTION

Margo would like the Board to approve money for rape prevention training. She is looking for input and ideas from the Fair family. The Board will discuss this at its next meeting.
