
Thanks so much for including the photo of the *putti* in the August *FF News* (page 6).



Tom Alexander



I have been a worker at the Nearly Normals booth since 1980 and worked in the Peace and Justice booth in Community Village from 1980 thru1994. One thing I have realized being involved as a fair family member is that the fair is like a four legged chair. The staff workers, entertainers, booth people and paying day visitors make up the fair. Anne Henry


I seek re-election to the Board of Directors of the Oregon Country Fair.



My nose to the smell of the wind and


stay alert.


My vote will reflect all input with direction to guide us as a group.

The Village Circle: Evaluation Meeting '95

This year's Community Village Evaluation Meeting and Picnic was held on Sunday, August 13, at the Community Village. Inadvertenly, this was the day after the Teddy Bear's picnic, so it gave everyone an ideal opportunity to camp out at the site and spend another weekend at the Fair.

About thirty people attended overall. The first thing we did was put everyone to work hauling leftover poles and lumber from the woods and swamp and storing them in the lofts for the winter. Then we enjoyed a delicious potluck (too many pasta salads), accompanied by stimulating conversation regarding the future of the Village Resturant. Alpha Farm, which has operated the Resturant for many years, had announced their intention to make this their last year at the Fair.

A lot of ideas were tossed around, but the one with the most support seemed to be to run the Resturant as a co-operative project of the Community Village, utilizing experienced Village Resturant staff who wished to return, as well as other campers and youth from CV. It was decided to form a Resturant Sub-Committee that would meet the 4th Monday of each

month at 33261 Bloomburg Rd. Anyone interested is welcome to attend and participate in planning for next year.

By the time we got around to starting the Evaluation Meeting, our numbers had dwindled to 17—but they had plenty of comments. As is our tradition, we went round and round in a circle until no one had

anything left to say.

Steve: What I have here is an Indian Stick. It's made of myrtlewood and has been blessed by tribal elders. The one who holds the stick has the floor. When you finish talking, pass the stick to the next person.

Janet: I had a vision of a world covered by little villages like this one and no cars.

John: We've been talking a lot about how things are changing—like Alpha withdrawing from the Village Resturant. What do we do for the next 25 years? How can we have an impact on our larger community? The Fair needs to continue to grow and evolve or the magic will die. Sitting in my tent this year I got a vibe feeling of people cashing in—like people are tired of what they did to create this and now just want to cash in. Lots of people who followed the Dead will need to find new directions.

Jen Lyn: I had the Fair picnic listed wrong in the Village Guidelines. Also, I listed the opening time for day pass people wrong—the gates are not open at 8:00 a.m.—which caused some jams in the parking lot. Working admissions was great fun, and I got to meet lots

more people from outside CV. I attended the Co-ordinator potlucks and tried to meet one or two new people at each meeting. The Fair was pretty good as reality goes. Everytime I went somewhere to meet someone it didn't work out but I always ran into them when I needed to.

Katherine: I'm concerned about our right and ability to gather together. Working too many hours at the Fair does not leave a lot of time to enjoy the magic. There's been some frightening things happening—Jerry dying, the Vortex. There are forces challenging people's ability to gather. I'm glad I came to the picnic—people were really enjoying each other and loving each other. But the OCF needs to be involved 'out there.' Maybe mediation could have avoided what happened at the Vortex.

Sally: I co-ordinated the Resturant this year and had my most fun Fair! I had people willing and able to take on aspects of co-ordinating so I was able to get out and enjoy the Fair and have lots of fun. We did well financially—not as well as '94 but maybe that's because we had more staff to feed. I have mixed

feelings about this being the last year of the Resturant—Alpha will have an evaluation meeting soon and we'll talk about it. We still want to be a part of the Village but in a new way—maybe plug in with Neighborhoods & Communities. It's always frustrating being so busy with the Resturant that there's no time to meet people and find out what else is going on.

Clif: We need to keep asserting what we think is important in the world. If the Fair is swelling maybe it's time to bud off new fairs. Plant seeds other places. After all, the spirit of sharing beats Costco. The OCF now has a web page and the CV will have one soon. People will start asking how we do this and we should be willing to share.

Steve: I see myself opening to change with the Fair providing guidance. I find myself drawn out to meet with the spirits who have dwelled here. I came to my first Fair 20 years ago and something inside of me changed. Twenty years of Fair magic—selflessness, gathering, community, children, song, accepting change—is filling me up. I try to stay open to the things said at meetings and be part of the solution. I had a wonderful Fair,

reading medicine cards to the general public. I can sense without knowing that it will take a lot of work next year. I'm ok with that.

Cindy: Sometimes I feel afraid and tired of politics. I wanted to get out of the CV Council this year—too many meetings—but then admissions opened up. No a.m. meetings and lots of hours. I really missed the morning circle and connecting with people at the beginning of the day. I know someone needs to be out there—I just don't want it to be me next year. I don't think there's enough done for kids, for example kids not being fed at Main Camp even though their parents were workers. Children are a part of our community—not just their parents responsibility—and someday they will take over. I was also bothered by the sweep. People shouldn't use their position to sneak people in—we should all stick by our guidelines. I had a dream (more on this in a future Village Circle). I think the Fair needs a Lucy Booth—people can talk gripes, politics, whatever affects them—and someone will listen and record their comments and pass it on to the OCF.

Tom: I came here as an S.O. two years ago. Both years I wasn't involved much in the preparation, but this year I felt more a part of the Village. There's a different energy here—more spiritual, restful, peace-

ful, tolerant—as the Fair is to the rest of the world. I welcome the opportunity to share with this community and I want to be more involved next year and give something back to it. My personal life has not been calm—turmoil, turmoil overwhelming—but I found peace here. The spirit of tolerence is what made it happen. The CV doesn't exist on this spot—we bring it with us and it blossoms here. The spirit of community exists and we create it!

Marie: This was my third Fair and the best experience yet. I felt more present, aware, sensitive to energy shifts and people's needs. It felt positive. There's a hard side to me—I can't speak real clearly about it—I experienced bodies walking around but people were leaving them. Is this an old Indian burial ground? Or perhaps it was the level of drug use? I work with healing energy—helping people return to the ground and center themselves. It's not a criticism—just sharing.

Jar's Soak







An article explaining the fair's non-conforming use\grandfathered status and its potential for "normal growth" would help answer questions as to holding other events, camping etc.

19. More electric carts to substitute for cars in the eight, or teen cart teams, or horsedrawn wagon. How about a cart designing contest? This could lead to a cottage industry. Flat carts carry more. Fewer cars in the eight a must.

25. Could registration send information packets to all who request them, not just the booth reps? Some reps don't pass them on to booth members.







<u>Motion</u>: Jim moved to postpone the naming of VegManEC co-coordinators until the October meeting.

<u>Background</u>: The VegeManEC crew nominated Marlene Showker and Philip Guyette to be the crew's co-coordinators.

<u>Board Discussion</u>: Jim said he would like to talk to Bill Verner about these appointments before he makes a decision. Daniel said he could not support the nominations at the time and also wanted to talk to Bill. He volunteered to gather and share more information about these appointments before the next meeting.

David said he would rather wait until the full Board is present. He would like to take a closer look at crew coordinators appointments and evaluations.

Jeanne and Paxton expressed the desire for more information before making a decision.

<u>Vote</u>: The motion passed, 7 for, 1 (Steve) opposed.

Elections Committee

<u>Motion</u>: Jim moved to appoint Erica Lerch, Heidi Doscher and Mira Rainey to the Elections Committee. Martha seconded. <u>Vote</u>: The motion passed, 8 for, 0 opposed.

Endowment and Board Discretionary Funds

Steve Wisnovsky made the following six motions at the same time, (what a busy guy) with the intent of tabling them for further discussion until the October meeting. All motions were seconded and some even discussed. <u>Motion</u> #1: Steve moved the Board transfer \$25,000 of this year's revenues to the OCF Endowment Fund capital. Tom seconded.

Motion: #2 Steve moved the Board add \$______ to the upcoming grant cycle to maintain current funding of local arts grants. David seconded.

Motion #3: Steve moved the Board add \$_____ to the upcoming grant cycle to create "Wooten grants" to provide initial funds to new organizations/projects that share the OCF community vision. The Endowment committee will develop specific criteria, including geographical limitations. Martha seconded.

Motion #4: Steve moved the Board eliminate (zero out) the Board Discretionary Fund. David seconded.

Motion #5: Steve moved the Endowment Fund Committee provide a yearly report to the Board and Fair family detailing its financial activity and plans and hopes for the future. Martha seconded.

Motion #6: Steve moved the Endowment Fund Committee advise the Board on the feasibility of hiring a grant writer to both assist potential grant applicants and to seek out grant awards to add to the OCF Endowment. David seconded.

<u>Public Discussion</u>: Steve Gorham said the Board Discretionary Fund process . The Board needs to decide if the process is acceptable. Right now someone comes to the meeting asking for money, it is put on the agenda as new business, then voted on at the next meeting

Mike James would like to see us have a volunteer grantwriter and explore the many grantwriting resources available (books, classes, etc.).

<u>Board Discussion</u>: Jim agrees with Mike that a grantwriter should be a volunteer from the Fair family.

David said he likes the idea of the Discretionary Fund being a subcategory of the Endowment.

Paxton is not in favor of making the change from the Board Discretionary Fund to the Endowment. He also wants to do a motion by motion discussion of this topic at the next meeting. Paxton is concerned about the extra work this puts on the Endowment Committee.

Martha feels it is appropriate to enlarge the Endowment to look at more than arts in Veneta/Elmira but she is not willing to give up the Discretionary fund to do that. She is concerned about groups who come to the Board with requests for emergency funding, such as the shower for the homeless camp or Bill Wooten's memorial service. She is afraid there won't be money or process to help them out.

Daniel applauded Steve's effort and thanked him for developing these motions. He said it is very difficult to budget for unforeseen requests with no process or time frame to administer those funds. The Endowment Committee is a good opportunity for people seeking contributions to work through and understand a funding process. He disagrees that funding requests are emergencies.

David suggested the Endowment Committee be a year round crew, receiving passes, so they wouldn't feel burdened by extra work. He feels they would be qualified to develop funding criteria that the Board would approve.

David reminded the Board of Leslie's suggestion that the OCF buy memberships in organizations with the money it has been giving away. (leslie at this time was asking the oracle of delphi what to do.) David thinks the Endowment Committee can handle the bulk of the Discretionary Fund and the Board can have a small amount of money to work with.

Steve said he intends to table the motions partly so that he will have time to talk to the Endowment Committee members. He would like to attract specifically qualified people to serve on that committee.

Steve said if the Board continues to have problems defining its discretionary fund there will continue to be more and more people coming to the Board asking for money.

Jim feels the problem with the present funding process is a lack of discipline on the Board's part.

Daniel said the Board has no discretion in making contributions; it's a terrible process. He totally supports doing away with the Discretionary fund and perhaps coming back to it in the future.

Paxton is in favor of continuing the discretionary fund as it is. He said the Board has come very close to sticking with the budgeted figure and, in fact, he would like to see that figure raised. OCF contributions sometimes make a significant impact. He sees no problem in setting and keeping limits.

<u>Motion</u>: Steve moved to table the above six motion until the October Board meeting. Tom seconded.

November Board Meeting

<u>Motion</u>: Martha moved the November meeting be held November 13. David seconded.

Background: Reggie and Lil Soto are coordinating the OCF contingent in the parade which will have horses and their riders, bikes and their pedalers, a band/orchestra and its musicians, walkers and their feet.
