For those of you who have indicated your support of this issue through your signatures, thank you! We collected over 600 signatures. I am quite hopeful that the proposal will be on the October ballot.

I strongly urge everyone to vote in favor of this "voice for the members" and to let your OCF Board (BoD) representatives know that you support ange to our By

this critical change to our Bylaws.

A copy of the petition appears in the current issue of the Fair Family News.

I believe the Survey is an important step for the Fair because it provides the Board and the Membership with a means to communicate. As it stands, there is no effective procedure to inform the BoD about issues that the Membership finds important. This has and will continue to (in my opinion) lead to member apathy and frustration.

The proposed Survey would allow both the BoD and Membership to develop a list of issues that could be a working agenda for a 2-year period, allowing everyone to be able to anticipate future discussions and possible decisions on a particular subject. The process for developing the Survey questions (refer to Petition text) is meant to give all issues a fair chance to be heard without bias.

This may not be the ultimate solution to all of our communication problems, but it is a good start. I urge you ALL to vote in the upcoming election and to encourage other members to vote...it is IMPORTANT to us all.

#### **Petition for Survey**

(The following petition will appear on your election ballot.)

#### WE THE FAIRIE PEOPLE...

Purpose of our Petition

We the undersigned members of the Oregon Country Fair (OCF), in the Fair spirit of a democratic organization, request an amendment to the OCF By-laws instituting a bi-annual membership survey conducted by the OCF Board of Directors (BoD). The purpose of the survey is to provide Board members with an opportunity to be responsive to the concerns of a broad, cross-section of the membership, and to provide members with a forum through which to express their concerns, ideas and desires.

By-law Amendment (Survey) to be Placed on the Agenda of the 1998 Annual Meeting

We further request that this by-law amendment be put to the membership as

part of the 1998 OCF annual meeting and election process. Results of this vote by the membership would be tallied by a non-partial, ad-hoc committee appointed by the OCF BoD. If the amendment change passes by a simple majority of those voting, we the membership request the Board to make the by-law change so that the survey will become part of the election process on a bi-annual basis.

#### Administration of the Survey

- •Survey to be comprised of items put forth in the form of yes/no opinion questions and/or preference questions.
- First survey to be conducted during the elections of 1999.
- Any verified member may place item(s) on the survey through a separate petition process requiring at least 25 registered member signatures.

- Survey items must be submitted to OCF at the same time as the candidate statement deadlines.
- Finalized survey questions and the petitioners statement/explanation will be included with the published BoD candidate statements in the *Fair Family News* and the voter's pamphlet.
- Results of the Bi-annual survey will be tallied by a non-partial, ad-hoc committee appointed by the BoD and will be available to the BoD by the annual retreat.
- Results of the survey will be published in the *Fair Family News* no later than the December issue.
- Survey items supported by a simple majority of the voting membership will be scheduled to discussion at a special BoD/membership meeting to be held in January of the following year.



## VegManEC Visions

Another Fair has come and gone, and most people left with wonderful memories of magic and fun, and special purchases or gifts. Unfortunately, many of them left things behind that are harmful to the land. The Fair site is a beautiful and magical place that most Fair family sees only a few days of the year. To keep it this way takes countless hours from the site manager, caretaker, and the year-round crews who maintain this land we all love. This year the cleanup task has been especially difficult due to the extraordinary volume of straw, hay, wood chips, furniture, and other floatable materials that were left behind. The debris must be cleaned up before the floods.

Literally tons of straw and hay were left in booths and campsites this year. Straw and hay left on the site creates several problems, one of which is fire danger. The site already had one unexplained fire involving hay since the Fair, and one of our neighbors recently lost a house due to a fire. Another problem resulting from hay or straw left on the ground is the inhibition of understory growth. Much of our groundcover is dead after the Fair and needs time to recover; hay and straw retard the necessary re-growth. Without ground cover, the topsoil erodes away during the floods. The loss of understory also weakens the overstory, resulting in the loss of our majestic trees. The trees,

plants, flowers, animals, and insects that live on our site are all part of the "Fair magic;" they depend on us to preserve their environment. Next year, IF YOU PACK IT IN, PLEASE PACK IT OUT (WHEN-YOU LEAVE)...TAKE ONLY MEMORIES, LEAVE ONLY FOOT-PRINTS.

You're all invited to join the VegManECs the first Sunday of each month for an organized work party (we meet at the warehouse at 10). ## Report of the 1998 Annual Oregon Country Fair Booth People's Meeting

e began our meeting by read ing the minutes of our first gathering, OCF 1989. Of the visions shared at that time we happily note that most have manifested over the years, thanks to the cooperation and fine efforts of the Country Fair Family. (Advance ticket sales, paying-off land, more water and outhouse facilities, off site camping, SOP passes, a new loop, trade circle accommodation, reinstating the OCF Craft booth committee).

In recognizing that the majority of the staff are local and organize year round to take care of the Fair, we want to find ways to improve the relationship between the local family and the far flung crafter cousins. We want to feel welcomed rather than that we are crashing someone elses' party. The Fair's reunion now spans two generations for most of us crafters and its significance in connecting with and strengthening our sense of family and community runs deep. The Fair Family News provides a forum that we would like to make even better use of, such as articles describing details of the 5 Year Plan, construction guidelines and regulations, path planning policies, names and numbers of contact people to answer questions as summer approaches. We would like the Craft Committee to become a bridge that goes both ways, communicating staff policy to crafters and working with the crafts people to meet their needs in determining policies that affect them.

We welcome Kim Allen (Characters in Clay) and David Peek (The Mocassin Co.) to the Craft Committee. The fact that they are willing and able to attend the Thursday meeting at the Fair brings joy to our hearts. David has gone so far as to volunteer to compile a Crafters' Mailing List to be used among the OCF family. If you did not get the Blue Sheet and want to be in the catalogue, call David at 541-935-2061. Jeff Harrison of Craft Inventory is also beginning to compile a list of all crafters from each booth, rather than the booth rep only.

He can be contacted via the OCF office. Voices and Visions 1998 (Griping happens when communication doesn't.)

- 1. We left many messages with construction concerning our booth's accidental destruction. No one ever replied.
- 2. There are no cohesive construction guidelines. All seems arbitrary. What are the county and fair guidelines? Can they be put in *FF News*?
- 3. It is not fair to arbitrarily move an 18 year crafter's booth to accommodate a food booth. Neighborhood is everything. Our livelihood depends on it. It sets a bad precedent. Open up to communicating rather than dictating. Enclosed is a petition signed by 24 people stating "We do not support displacing a craft booth for the purpose of putting a food booth in its place." (Ed note: Petition has been given to General Manager.)
- 4. What happened to the "Neighborhood Staff Contacts"? They were a helpful, welcoming staff presence during past fairs. Please reinstate.
- 5. The spirit of this event is "doing it different" and not becoming just another commercial venture. Serving the public first and the crafters last doesn't feel good. We're trying to set the example of family first, then business.
- 6. Have Thursday of the fair open to the Fair community so that we can avail xourselves of information resources, crafts, and comraderie.
- 7. Make it mandatory to have reps from construction, BOD attend this meeting so we can ask questions and be better informed. (We missed you this year, Paxton.)
- 8. Have a feast for the staff and BOD Wednesday night of Fair to show our appreciation and share information.
- 9. The Crafts Committee needs to be a voice for the crafters to the staff, not the other way around. They do not make themselves available to the craft community and are closing their meetings. This has to change.

- 10. Public attendance is maxed out. Less is worth trying.
- 11. Are we pricing ourselves beyond the reach of the general population's shrinking dollar? (Parking, admissions)
- 12. Interact on the Internet at earthdance.com.
  - 13. We need craftspeople on the board.
- 14. The jurying system pidgeon-holes artists. It does not allow for collaborations. We want to recognize our master crafters via an agreed-upon standard and allow them to bring whatever they are creating. Trust us, trust us, trust us.
- 15. Have a hearing to create policies to deal with jurying, non-functioning booth reps, party booths, how long to be in a booth to qualify as a permanent member, etc. Get booth histories, crafters' input (Questionaire). People are willing to travel long distances to be heard. We need a committee willing to work these issues out using a democratic process. (Vote)
- 16. Having the Fair Family picnic on Saturday excludes Saturday Market crafters from being able to attend.
- 17. The Rainbow Tribe meets once a year to plan their event. Can we learn something from them?
- 18. We treasure this privilege to gather together and celebrate: not only our families, our fabulous feasts, our music and dancing, our artistry, pagentry and magic but also our visions of unity, sustainability and cooperation. As Carol K. Anthony says, "We view others as adversaries when we give up on them." Some of us work away all year and travel far to attend, contributing our efforts for the few special days of the fair. We have been coming here for 2+ decades (more or less) If the staff only tolerates our being here, feels overworked or under-appreciated, we want to heal this. Don't give up on us. We are your greatest allies. Tell us what you need. Respect our needs.

## The Law Reform Group



Hello, my name is Doug Carnie (aka Woggle) and I am seeking an open position on the Oregon Country Fair Board of Directors. I have been involved with the OCF as a volun-

teer and part-time employee over the last eight years. I served as thirty-day Quartermaster for six years and the last two in Fair Central.

Above all else I would doggedly advance the idea that the Fair is about people and ideas. The Fair's most valuable asset is its people. From us comes the magic.

Second, the organization should live by the values it espouses: integrity, equality and tolerance of different view points. We should never lose site of the fact that we are all family.


Third, we must remember our obligation to protect and care for the land and all who live there.

We need everyone's involvement, not just Financial Planning's.

#### **COMMITTEE REPORTS**

Land Use Management Planning (LUMP). Dennis Todd reported that the wetland restoration project got a late start. The replanting and seed bed preparation will happen next year. Both, Dennis & Leslie have been meeting with the city manager and city engineer of Veneta to discuss the land swap. The city's original projection of their needs 20 years from now, 41 acres, would take up most of the Far Side camping area. The results of the soil percolation test that Dennis requested show the soil has five times greater absorbency than assumed. Thus the city engineer now projects their needs at 30 acres. This leaves all our prime camping area available. We seek a shared use agreement to take effect in October of 2017. The Fair and the city agree in principle and are working cooperatively. Jack questioned the city's intentions to spray or use drip irrigation. The Fair will insist that all areas the OCF or the public uses will use drip irrigation. Effluent from the upgraded water treatment system renders the applied areas safe after 24 hours.

LUMP seeks new members. Anyone with interest and experience in geography, land use management, natural resources, etc. is encouraged to apply. Send a letter of introduction/interest to the Fair office.

Election Committee. Jen-Lin stated that the Annual Meeting will be held Saturday, 10/17/98 at 6:30pm at the WOW Hall. Meeting invitations have been sent to members today. We have fourteen candidates for seven positions; it should be an interesting campaign. The deadline to request an absentee ballot is Friday, September 18,5 pm, at the Fair office or in the Fair's PO Box. No absentee ballots will be available at the Fair office. Absentee ballots must be returned to the Fair office or PO Box no later than 5pm, Friday, 10/17.

#### **OLD BUSINESS**

#### **VEHICLE SHED**

Steve W stated that there is no current motion. \$5,000 has already been allocated for this capital project. He believes we can begin building a somewhat scaled back version of the original plans via old barn raising work parties. The calls will soon go out to those construction types. They eliminated the repair bay slab and plan for only 7, not 8, bays. He hopes

he can find additional monies yet unspent in the Site Manager's budget. However, he may need an additional \$2-\$3,000 at the tail end of the project. He contends that we need to start building now before the rains come to protect our assets. Hilary expressed concern about a possible 40 percent increase that could be forced at the end to complete the project. Jack confirmed with Steve that the vehicle shed the total budget approved by the Board for the vehicle shed is \$5,000.

#### **VAUDEVILLE CO-COORDINATOR APPOINTMENT**

Paxton moved, and Charlene seconded, the BoD appoint Shelly Winship as the Vaudeville Co-coordinator.

BoD Discussion: Paxton said this was requested by vaudeville crew in their letter dated 6/26/98. Charlene said that Cory Sullivan (Ambiance Entertainment Coordinator) is supportive of this appointment. She said that Shelly is a strong person and will be able to work well with the other co-coordinator, Mick Westrick. Jack thanked Tim Miller who is resigning as Vaudeville Coordinator.

The motion passed: 10 in favor and 0 opposed.

#### '98 ELECTION COMMITTEE APPOINTMENT

Paxton moved, and Daniel seconded, the BoD appoint/reaffirm the '98 Election Committee of Heidi Doscher, Merrill Levine, Tina Edwards, Jen-Lin, and Steve Gorham.

Peach Gallery: norma said this is the same great crew as last year. They've already begun to meet and are doing a fabulous job. Etienne requested that the number of votes each candidate receives be published.

*BoD Discussion*: Martha thanked the Election Committee for sitting in the basement tallying the results. It doesn't seem like a very fun job. (Nah, we have fun!)

The motion passed: 10 in favor and 0 opposed.

#### NEW DIRECTIONS FOR P.A.T.

Tom moved, and Paxton seconded, the BoD direct the Property Acquisition Team (PAT) to investigate the Fair's real estate options regarding the Swanson and/or Hubbard properties should they become available.

*Background*: Both properties are above the flood plain and are contiguous to Fair property along Chickadee Road. The Swanson property has a house and other buildings for storage.

Peach Gallery: Many spoke enthusiastically in favor of owning the Swanson property. Palmer wondered if this motion was necessary and whether the Fair wanted to make its intentions known publicly at this time. However, David H. (CV) thought the neighbors must know the value their land has for the Fair. David Helton (Registration) urged the Fair to employ a commercial real estate appraiser based upon our experience purchasing the Fair office. Anne Morris (VegManECS) wondered how the Fair could purchase property while we have financial concerns. Andyman said that Veneta is a growing community; property values will continue to increase. Etienne proposed making the house on the Swanson property a volunteer work house

BoD Discussion: Martha wondered who the current members of PAT are. The motion that created PAT stated that its members would rotate every three to four months. (Seems as if that aspect has lapsed.) She also remembered that the same motion charged PAT to take similar action as stated above. This motion is redundant. Michele concurred. Tom stated that in discussion with Steve W it wasn't clear whether the investigative process was continuing. He raised this specific topic to stimulate discussion and to avoid complaints that the Fair acts in a secretive manner. Steve W, also, told Marlene recently that the Swansons were approached a year ago and they had no desire to sell. She wondered if the price was right they may be willing. Paxton thought they may be more interested if we could offer specific terms. Jack said neither property is an absolute must. The Swanson property, 5 acres, could be valued at \$100,000. That could strap the Fair to balloon payments which would come out of our operating budget. Charles expressed similar concerns about the financial picture even though he supports purchasing these properties. Tom stated that it would be in the Fair's best interest to facilitate the group that does purchase the property. Martha echoed Tom's statement. She remembers past discussions about the Fair holding land temporarily and writing covenants on its resale.

PAT should be reconvened. Letters of introduction and interest to serve on the Property Acquisition Team will be accepted at the office. The motion passed: 8 in favor, 1 opposed (Michele) and 1 absten-

tion (Martha).

Land Swap is tabled until the October BoD meeting and Cap Reduction is tabled til the November BoD meeting.

The next BoD meeting will be held Monday, October 5, at EWEB, 7pm. The agenda, subject to change, may include: Land swap, Craft Committee (Paxton), Consider forming Crew Services Crew (Charlie), Donation to Saturday Academy. Appointments: Youth Stage Coordinator, Chela Mela Area Coordinator (Charlie), Create Co-Secretary position (Marlene), New Traffic Co-coordinator (Steve G), Admissions Coordinator (Michele), LUMP and PAT members.
