



#### The Cosmic Gong Is Ommming

The Fair Ommming Circle is returning to cosmic origins for our 30th anniversary celebration. Michael Om of Community Village's Spirit Booth and Guruprem Kaur of Health and Healing are two organizers of the Fair Ommin Circle, which will encircle the Fair on Sunday at 10:30 a.m.

This year they will help Fair Family sing a gong-like OM, by resonating our upper palates and nasal passages, leaving off emphasis on M. In fact, there is no M in the symbol of III OM. Just a smile-shape with a dot on top. Looking into Sanskrit reveals that this dotted III smile is nasalization.

Try it and you will find you are heavily resonating your III third eye and pineal. Do it really powerfully, like playing a cosmic gong, and you can soon feel dissassociated from your body!


Sex Offender Policy

The following motion was adopted as policy at the May 1994 Board of Directors Meet-

(1) Adjudicated sex offenders who are not currently in, or have not successfully completed, a sex offender program with a licensed counselor, are not welcome at the Fair as employees, staff, volunteers, contractors, entertainers, or significant others. (2) Any person wishing to shall present documentation of an offense to the General Manager, who is granted the authority to bar said offender from entering the property, and may designate whichever crews necessary to enforce that prohibition. (3) Any coordinator or Fair staff person who is presented with aforementioned documentation will immediately report that information to the General manager. (4) Any person barred from the Fair property may appeal exclusion through (a) the Grievance Procedure, or: (b) in June and July, when the Grievance Procedure is not in effect, the Fair president.





#### The Jill Heiman Vision Fund A Real Eye-Opener



Where but the Fair would you be able to magically turn a dollar into two AND contribute to the larger community at the same time? It's one of the beauties of the Jill Heiman Vision Fund. Started in 1996, the Fund memorializes Jill Heiman's impact on the Fair, and allows the entire Fair Family to support other non-profit organizations in the important work they do.

Here's how you can help: drop your donation in one of the wooden Jill Heiman Vision Fund boxes located throughout the Fair site (there's one at every Information Booth and at the White Bird medical booth). Volunteer Fair staff can also donate food voucher(s) in Vision Fund boxes. Vision Fund volunteers will be stopping by each food and craft booth some time during the Fair as well or boothpeople can add their donations to one of the boxes. The Fair will match all donations, penny-for-penny, up to \$10,000.

This year's funding category, as chosen by Fair Family members during our annual Board of Director's election, is "Basic Needs." Over 20 proposals from qualifying non-profit organizations were received and, with the help of friends like you,

Vision Fund recipients this year will be: \$5,000 to two projects by Looking Glass's New Roads program. One is a school internship program providing homeless youths with education and employment opportunities. The second proposal is for a night-access program offering evening meals to homeless youths; \$2,000 for a greenhouse and educational materials for Northwest Youth Corps' new Youth Works



program where youth aged 14-19 will develop and operate a two-acre organic garden to feed hungry people; \$3,000 toward commercial-grade washers and dryers for St Vincent de Paul's Eugene Service Station (ESS) expansion. ESS is an outreach program for the homeless of all ages which served over 4,000 clients last year with emergency assistance, restrooms, phones,

mail drop, counseling, referral and more.

The Vision Fund is a great way to carry on the Fair's mission beyond the three days of the event. Past recipients include Food for Lane County, Centro Latino Americano, Oregon League of Conservation Voters, First Place Family Center, and Northwest Coalition for Alternatives to Pesticides (NCAP).

Jill Heiman contributed in a major way toward the Fair's evolution into the event you're a part of today. She coordinated the effort to turn the Fair into a non-profit organization. She was a leader in the negotiations to purchase our current site in 1982, and her successful lawsuit against Lane County for threatening the Fair's constitutional right of assembly was instrumental in the fundraising effort which resulted in this purchase. She is also the namesake of Jill's Crossing, the wonderful wooden bridge on the Fair path between the Left Bank and Strawberry Lane. Jill died in 1991 during childbirth.

The Fair is proud to honor Jill's memory with the Jill Heiman Vision Fund. We invite you to join us in our contribution.







### Poison Oak Control



There is NO guarantee the Vegmanics can remove all the poison oak at the Site. There is lots of it (this is the Oregon COUN-TRY Fair), and even if removed, structures and remaining foliage may be contaminated. And we are known for our hugs.

Removal will be on a priority and time available basis. First priority for removal is in or near public areas. Next are major trailheads, major support areas, and high traffic areas. Low priority: sites having little effect, sites in preserve habitat/green areas where people aren't supposed to be anyhow, sites where it is used to restrict entry. NOT on removal list: sites where it is allowed as a native heritage plant.

Please! For all our sakes do not false alarm! DONOT CONFUSE POISON OAK WITH BLACKBERRIES! True, they booth have leaves of three and the leaves all join at a single point but poison oak (actually a sumac) leaves are soft-curved in an "oakish way", hence the name, while blackberry is more round shaped with sharp, sawtoothed edges; and easiest of all, poison oak does NOT have thorns. NO THORNS ON POISON OAK. Leaves are usually shiny green (not red until fall) and it can grow as a ground runner, tree vine, or as a bush.

There are a few people known to be poison oak tolerant and some of these work this crew. If there are others who wish to anonymously remove any poison oak, Fair Family will be thankful for an unseen act of removal.!

If you find yourself next to it in a low priority site there are five options: 1. Report and flag it and something might happen, 2. Go away, 3. Cover it with something, 4. Move it with pooper-scooper tools of a stick or hand-in-a-plastic-bag style, 5. Warn your neighbors as a courtesy and an "anonymous" may deal with it.

If you deal with it, please flag it and report it, in case it resprouts and/or so we can remove it post-Fair.

To report poison oak: (a) go to quartermaster, (b) make entry in book: be specific, a map is helpful, (c) get flagging and flag it or near it.

Poison oak prevention and first-aid cream are at Quartermaster or White Bird.

### Interview with Tom Alexander

Tom suggested we do his interview by e-mail, since it was hard to figure out when we would have time to meet. I asked questions and edited, but Tom did the writing!

What is your involvement at the Fair other than Board work?

Since the 1981 Fair I've worked at the Nearly Normal's food booth across from the belly dancing stage. I'm a hawker and order taker, where among other things, you can order me around. From 1980 until 1993, I published Sinsemilla Tips magazine and was involved in the Community Village peace & justice booth, where I gave away copies of the Sinsemilla Tips. As the sweep swept the daily Fair visitors out of

the Fair, I stood outside the gates, near the bus line, and hawked copies of the magazine for whatever price people would give me. I called it the "Let's make a magazine deal!" I met a lot of interesting folks doing that. I also met a lot of long time readers of the magazine.

How long have you been at the Fair? If irst came to the Fair as a visitor in 1978. I wandered around with big eyes and my mouth wide open like I just had stumbled upon hippie Disneyland in the woods. I continued to go as a visitor until my involvement in Community Village in 1980. Idon'thave any stories of sneaking myself or anybody else into the Fair. I always was scared I would get caught and bebanished from the Fair.

Are other members of your home family involved with the Fair?

My wife and daughter work at the Nearly Normal's booth as food prep workers and order takers. They read the Fair Family News. That is it for their involvement. My son worked at

the booth but his girlfriend doesn't like the Fair and this will be the second one he has missed in his 19 years. It's hard to accept, but he has his own life to live.

What is your life like apart from the Fair? Iown two businesses in Corvallis. Since 1989, I've published Growing Edge magazine. Now with Growing Edge, I report on what is really happening in the legal horticultural and gardening world utilizing halide lighting, hydroponics and greenhouses and controlled environments, and the government claims we are really still a marijuana magazine and denies everything we report on.

Pictures don't lie. We have pictures showing legitimate crops along with stories about schools, NASA, Epcot Center and commercial growers to go with them. The government is full of shit. I am always a thorn in their side and try to show how much shit they are full of.

The other business I own is Old Town

Graphic Design. We do design work for other businesses and individuals in the mid-Willamette Valley. Our main graphic works are catalogs (both print and online), corporate annual reports, advertising material and business web pages.

What do you like to do when you're not working?

My main recreational activity is playing hockey. I play ice hockey at the Lane County Fairgrounds once a week and inline roller hockey twice a week here in Corvallis. I have played hockey since I was six years old growing up in Ithaca, New York. I played in college and a few years after college, but then took twenty years off. Four years ago I started playing again and

now hockey is my drug of choice. It is a great stress reliever, keeps me in shape and is a lot of fun.

The other physical activity that I love is gardening. We live on a little over four acres. When we bought it three years ago I committed myself to making it a little Garden of Eden. Almost all of our land is growing flowers, fruit trees, vegetables. I am always bringing home orphaned plants from somewhere. Garden centers and nurseries love me. We are looking into making part of our land into a greenhouse research farm for the Growing Edge. There are many new technologies coming out that increase yields and making growing easier. There is also a lot of research coming out of OSU on new organic methods. We want to research that also.

What's your favorite place to "hang out" at the Fair?

It's hard to pick a favorite place. I like the whole Figure 8 because no matter

where I am there are always multiple experiences happening in the general area. People interacting with people at the Fair are so interesting. The Fair is a really special experience AND experiment. I have seen drunken redneck cowboys bump into each other and help each other up off the ground with no hard feelings, while those same two cowboys might start brawling with each other if that happened in the real world. I know security or the big boys have had many different experiences, but inside the Fair, good vibes happen way more often than they do in the real world. It's what the Fair Family calls the Fair magic.

It's nice to be part of a booth in the Figure 8 because if I need to unwind and get away from the high energy of the paths, I can retire to the couches and chairs in the booth's living room or take a nap in my tent.

What inspired you to run for the Board, and when did you start your first term?

I originally started to think about running for the Board when the recall took place in 1991. A few years passed and I thought I had the answers to a lot of what I thought were problems. After getting elected to the Board in 1993 and attending the Board retreat right after the election, I realized I didn't know what the hell I was talking or thinking about regarding the supposed problems of the Board and Fair. There's a lot of background information buried in past board meeting minutes and decisions that most people forget about or don't know about since they weren't at the meeting and missed reading the minutes. Even people who attend meetings forget details about what took place.

When I first ran for the Board I had only attended a few Board meetings. Some people feel that should disqualify someone from running for the Board. I disagree, if, and only if, that person has an open mind and really has the Fair's best interest in mind. If a person has a hidden agenda and a closed mind on options then there will be problems. The Board retreat and related printed materials bring a new Board member up to speed pretty quickly if that person will listen.

I am not running for re-election this fall so I will REALLY miss working on the Board. I have learned a lot of things that will help me in my businesses and in politics. Ilike politics. In many ways, politics is like sports. I strongly encourage people to get involved with the Fair throughout the year. There are so many opportunities to work on Fair business year-round.

What hopes/dreams do you have for the Fair? What has been your contribution as a Board member?

One of the main dreams I have is building a lodge/showers/kitchen/community meeting place on non-flooding high ground. It would enable the volunteers who work so hard year-round to have a place to rest, eat and get cleaned up after working at the site. It would also encourage more meetings and gatherings at the site during the year. When we hold miniretreats at the site during the spring or fall it has special energy that is missing when we meet off-site.

The other hope I have is that we think about the growing internal Fair Family. However we control public growth, our internal growth is inevitable. I campaigned for re-election on the platform of dealing with our kids becoming adults and how the Fair is going to cope with that reality. Some booths have more kids than adults. In five years those teenagers are going to need a way to participate in the Fair.

The folks who are against Fair growth have their heads in the sand. Growth is happening as we speak. How the Fair will deal with internal growth is the main question. Hopefully, the evolving elders concept will help.

Some contributions I've been a part of include the internal growth issue, paid parking, long range planning, and smaller second events. I think we should explore getting the Fair rezoned into a fairgrounds/ convention center.

Over the past few years, the Oregon Country Fair has become a Veneta event. As the outside satellite campgrounds have shown, it is much bigger than just our OCF site. The more it grows into the community, the more the community feels a part of the OCF. So I support focusing our external growth more into the Veneta community.

What can you tell us about yourself that might surprise people who know you at the Fair?

We like to be wild and crazy at the Nearly Normal's booth. Sort of add entertainment to your Fair food dollar. So a couple of years ago we added Sunday morning drag queen/cross dressing to our schedule. It's a pretty wild time, with all kinds of verbal barbs from the queens to our customers and concludes with the crowning of the Queen of the Fair. We like to say that we ARE Victoria's Secret.

The parade's drag queens asked us to march in the Sunday morning parade with them and we obliged. After the parade was done, I was walking back to my booth. The gates had just opened. I ran into one of my main magazine advertisers who had ridden down from Portland on his motorcycle. The sight of me floored him. He said he will never view me the same again. That is the Fair experience—a person will never view the real world the same way after coming to the Oregon Country Fair!





#### OCF Daily: A New Vision








#### Craft Committee Notes

We began the meeting by listening to Leah Traister make an appeal of the jury results for members of her family's booth. This booth has been a face-painting booth for a very long time, but the younger family members have had trouble jurying into the Fair. Leah made a case for the idea that face-painting is a unique craft, in some ways more like a service, and should therefore be juried in a different way than other crafts.

Jim Sahr and others expressed a desire to find some way to accommodate Leah's appeal, especially given the Traister family's longtime presence at the Fair. Jeff responded by saying that if we change the rules for face-painting we run the risk of the whole craft jurying process falling apart. Vince asked whether face-painting could be handled by the esoterica jury. Thom responded with some of the history of the jurying process and explained why Vince's suggestion might be unrealistic and not really solve the problem. Dana and Wren, among others, noted the need for more crafts that are both oriented toward children and affordable for parents (i.e., under \$5). Many ideas were brought up for how the Fair could become more kid-friendly.

The general feeling at the end of this discussion was while everyone had a lot

of sympathy for Leah, the Fair should continue the policy of not allowing appeals of specific jury scores. Leah was encouraged to come back to the Committee in the fall to renew the discussion of these issues.

We then turned to the topic of whether a questionnaire should be distributed to crafters at the fair this year. CC had decided at the April meeting that the Fair should require all crafters to give the fair their addresses so that it would be easier for the OCF staff to communicate directly with them (rather than through the booth reps). But how best to do this? Jeff pointed out that questionnaires had been handed out in the past but only about a third of them were returned.

Questions were raised about what sort of info we should be seeking; just addresses or other things as well? What will the OCF do with this information anyway, and who will compile it? Ken emphasized the idea of getting a crafter mailing list together is to improve the communications between the OCF and crafters so that crafters can feel more informed and welcome to participate in the decision making processes. Jim Sahr raised questions about confidentiality, pointing out that some crafters may not want to be found and might fear that the OCF would give their info to others.

Vince moved that, given the complicated nature of all this, no questionnaire be distributed this year. It was pointed out that this would delay the building of a mailing list, which Wren in particular thought was unfortunate. Vince modified his motion to the effect that Registration crew be required to gather addresses from crafters this year. Thom pointed out that CC cannot just issue orders to any crew. A variety of options for how to gather this



info was discussed, but in the end Vince's motion died, shipwrecked on the shoals of practicality.

Thom suggested that the best way to proceed would be to ask the Board to make it official Fair policy that crafters be required to give their addresses to the OCF. Jim Newhall said he would introduce a motion to this effect at the next Board meeting.

Vince then expressed a desire to discuss the practices of OCF staff's annual inspection of booths, which he says are too rough on the structures (one burning question: are anvils involved or not?). It seemed clear that many of the crafters present have strong feelings about this, but due to time constraints the discussion was put off.

The Committee then discussed and passed the following motion: "The Craft Committee recommends to the Board and the General Manager that no permanent craft status [i.e., permanent booth space or strolling vendor status] be assigned until the Board has established a Guidelines policy for assigning permanent space." The Committee members present made it clear that this means that no permanent assignments should be made for the '99 Fair. Jim Newhall said he would bring this before the Board at the June meeting.

The next CC meeting will be held Tuesday June 15 at 6:30 at the Fair office. The agenda will include: a discussion of the role that Craft Committee should play in the Thursday night Craft Guild meeting at Shady Grove; a discussion of the process for Committee meetings; more discussion of crafters rights and respor sibilities; and more discussion of Ken's motions concerning increasing the number of craft booths.

This letter is to let everyone know that 1999 will be the last year BRING will host Diaper Service. During the last seven years, over 1,400 cloth diapers were provided to parents who wish to avoid using disposables. We strongly encourage the Fair to relocate diaper service to a location more convenient and logical for parents, possibly Child Care or Community Village. BRING will gladly donate the approximately 400 cloth diapers we own and provide technical assistance (not much is needed!) to whoever wants to provide this great service. We strongly support parents who make the choice not to use disposables and hope that they will be able to continue renting cloth diapers at the Fair.







 Recognize the false sense of security that can occur. We think our children are safe. The Oregon Country Fair is an event with people who are familiar with each other. This should not interfere with common sense. The nature of the event attracts all types of people. The rules you use every day, especially for the safety of your children should be followed. If you do not let your child go alone to a mall, concert or sporting event, then do not let them on their own at the Fair. Be wise. Keep them safe. Have fun! Thank you.





**HUBBARY PROPERTY PURCHASE**

#### MEMBER INPUT

Julia commented as a parent that the designated smoking area located next to the Kids Space should be moved elsewhere.

Gale Hulihan (Traffic) read the following letter: "As much as the coordinators of Traffic want it to be over, the camping dispute has never been resolved. This is because the fundamental issues of the argument are policy issues and clear statements of policy with regard to them do not exist.

At the April meeting the Board determined that this camping dispute is an operational issue and turned it over to Fair management. At the end of April I wrote a letter to the General Manager which I intended for the grievance process. My complaint has been perceived as too negative, too broad and even threatening. It appears that my complaint will not fit the grievance process.

We will deal with this dispute operationally because we must,

but I think Fair Operations needs some help.

Population growth, seniority, the increasing demand of the next generation for empowerment and responsibility, how to best use and preserve our resources, and making the Fair accessible to new people are issues the Board has begun to address. Making policy for these issues must include discussing how we share the land. The sooner we can get to it, the better."

Marlene spoke as a VegManECs crew member: "This year, due to severe climate conditions and inadequate stewardship, we've lost a record number of trees and sustained damage to several more. These include the second largest tree on site, a noble fir near Main Stage. We also have had several small trees come down and have lost large branches out of an oak and a yew, not to mention the multitude of other broken limbs.

For me, when we lose trees, we lose not only the habitat, shade, ambiance and oxygen they supply but with the ancient ones we lose the living links that bridge our gathering place with those who have gathered here hundreds of years before us. We cannot control Mother Nature but we can be good stewards of our land and leave it, hopefully, in better shape for next 30 years and beyond. We can help the natural process by leaving as much understory and vegetation as possible. It is no accident that once an area has been cleared of the native vegetation we begin to lose our stately, mature trees. These trees are priceless; we won't be walking around here in the several hundred years it takes an oak sapling to reach its full potential.

By careful management and protection of the vegetation we can help keep healthy trees. There is a symbiotic relationship between trees and the understory. They need each other to survive by providing essential microbial activity in the root zone.

Ifeel that there is also a symbiotic relationship between us and the land and through good stewardship and reverence of the land we can continue to nurture each other. Read and use the LUMP plan (Land Use Management Plan) and the Guidelines. Please adhere to the Guidelines: No brush cutting. No nails into trees. No camping in designated green zones. Remember, VegManECs and Tree Crew are on site to help. By working together we can try to provide for the needs of our family and the needs of our trees."

Reggie Soto (Horse/Lot Crew) challenged Steve Gorham's letter to the editor published in the last issue of the Fair Family News.

Kevin Hilary (Crafter) of Whole Tree Works said he has been causally observing the trees on site for ten years. He would like to help the Fair with his expertise. By recording tree failures and creating tree maps and noting their present condition we could better manage, care for and project what will happen in the future. He has been talking with David Liberty, Steve Wisnovsky (Site Manager) and Hilary Anthony (Treasurer).

Raimon Franck (crafter): Kudos to the video crew for the great presentation at the Spring Fling. He encourages the Fair to take better care of our archives as was noted by the degradation of the video from 1980.

Norma announced that Dick Stewart (Recycling), after suffering a life-changing accident at the 1997 Fair, graduated from LCC last week with a degree in Multi-media Design and Production.

#### STAFF AND OFFICER REPORTS

General Manager. Leslie said Main Camp opened last weekend. Thanks to Steve W. and Andy Strickland (Caretaker) for their great preparations for set up. The Kitchen and Quartermasters were terrific. It was a happy and productive weekend.

Thanks to Jack and Palmer who accompanied Leslie to media interviews with the West Lane News and the Register Guard. The advertising and media coverage is much improved this year. If the weather cooperates, our attendance should definitely be up to projections. Thanks to everyone who helped plant the native trees and special thanks to Dennis Todd for his leadership and very hard work on this project.

The Respect Our Community's Concerns (ROCC) committee held its pre-Fair meeting. They are pleased with preparations so far. Some business folks took posters to display in their windows. They share our concern and were considering solutions to Oregon Dept. of Transportation's (OdoT) possible closure of Buck's Happy Campground.

Thanks to Marshall Landman (Crew Services Coordinator) and norma for creating our own web domain and to norma for her excellent job on the Spring Fling.

Leslie also requested Board guidance on requesting acquisition of the mitigation ponds from OdoT. A good piece of financial news is that we were successful in our property tax appeal, and will receive refunds not only for 1998 tax year but also retroactively for 1997 and 1996. The total refund with interest will be around \$5,8000, of which we will get half per our agreement with the attorney who did this work for us.

The Back-Up Managers (BUMs) for this year remain the same as last year: Sallie Edmunds, Grumpy (aka Steve Gorham), Zak Schwartz and Ben Sturgill. The swimmers (BUMs in training) are Floyd Prozanski, Doug Green, and Martha Evans.

Administrative Assistant. Norma announced that the new OCF web domain address is: <a href="www.oregoncountryfair.org">www.oregoncountryfair.org</a>! norma thanked everyone who helped with the Spring Fling. There's an article in the FFN saying who these lovely fairies are. The Spring Fling is almost self-sustaining, as raffle ticket sales practically equaled costs.

Thanks to the Office-Town crew for their help packing and moving the office out to the Fair site. It's best to call ahead to make sure where the office is on any given day since they will be both on—site and in town for the next several weeks. Thanks to Steve W. who lets her invade his office and encroach ever more each year. Thanks to Tom and Etienne who do such a great job maintaining the lawn at the town office and planting beautiful flowers. Carolyn Sykora will be on-site on the weekends to write reimbursement checks. It's helpful if all your receipts are totaled.

Site Manager. Steve said he is once again reminded that it is really norma's office and he just gets to use it for 46 weeks of the year! The site is green, wet, and soft. Please tread lightly. There is a nice, thick carpet of young grass along 13th Street. So, before you drive your vehicle in the 8, park your car, take a walk and think if it might be possible that your stuff could be hauled in by an alternative method. Check with Quartermaster for assistance.

Thanks to everyone who spent Mother's Day on site for the pre-Fair clean-up work party and thanks to all the fairies who donated food. Thanks to Tree Crew, Site Crew and Andyman for their great work preparing the site. There's still a lot of dangerous tree work happening. Please, keep kids away from these projects.

Come take a walk on site. It's absolutely blooming and lush. Appreciate what we have.

Treasurers. Hilary: Now we start spending the big money. Carolyn and norma will write reimbursement checks to coordinators with receipts. No one is authorized to set up accounts with businesses in the OCF's name or to spend over their crew's budget. Talk with Leslie, Hilary or Steve if this may become an issue. Steve reminded us that we still have a break-even budget planned, which may well become less than break-even as we face

unbudgeted expenses such as moving Maple Gate, which will be required by OdoT.

President. Jack said it was a privilege to accompany Leslie and Palmer to the Register-Guard interview. It was free-ranging and fun and he is interested to read the article when it is printed. Regarding the Office Compliance issues—in the long run we will have made the building more safe and increased the value of our investment.

Regarding brush cutting, Construction made a commitment five or six years ago not to cut any brush. They are presently at about 100% compliance. The brush is a valuable resource for the event as it blocks sight lines and protects privacy. We need to steward the land for the next 50 years and beyond. Jack urges all Fair family to become creative about guarding what's left.

#### **COMMITTEE REPORTS**

Archaeology. John Stamp: The floods caused great erosion to the river banks this year and redeposited some artifacts in X-Ray Park (an arrowhead and a spear point)! The Archaeology Committee will be doing testing and collecting samples for carbon-dating on the river banks on Monday, June 28, and Friday, July 2. Volunteers are invited; leave your name and number with the Quartermaster to be notified about the schedule. The media will also be covering the story. The Fair site is unique in that people have lived/gathered on this land continuously for 10,000 years. The committee will submit a request to the Board in July to finance the carbon-dating testing.

#### **OLD BUSINESS**

#### CONSTRUCTION COORDINATOR

Jack moved, and Dr. Jim seconded, that Kirk Schultz be appointed Construction Co-coordinator.

Peach Gallery: Leslie thanked Oso for his many years of working as Construction Coordinator. We appreciate that he is assuming an Internal Security Co-coordinating role now. Oso thanked everyone who has worked with and put up with him. (Jack and Oso hug!) Oso, acknowledging that Kirk's style is different from his own, believes Kirk will be a very efficient and good coordinator. He plans to help Kirk this year during the transition.

BoD: Palmer thinks that Kirk should be consummated however he chooses! Charlie agrees that Kirk is a great asset to the Fair and it is Kirk's choice to make and meet his commitments. Dr. Jim—Kirk is a great consensus facilitator and builder of collaborative efforts.

The motion passed: 10 in favor and 0 opposed.

#### KITCHEN CHECK SIGNERS

Charlie moved, and Michele seconded, that the Kitchen check signers are norma sax, Leslie Scott, Hilary Anthony, Steve Gorham and Eric Nusbaum. Eric is the new Kitchen Co-coordinator.

The motion passed: 10 in favor and 0 opposed.

#### **QUARTERMASTER CHECK SIGNERS**

Michele moved, and Dr. Jim seconded, that Carolyn Sykora be added to the Quartermaster account for the months of June and July 1999, with norma sax, Leslie Scott, Hilary Anthony, Steve Gorham and Steve Wisnovsky.

The motion passed: 10 in favor and 0 opposed.

#### FOOD VOUCHER CHECK SIGNER

Michele moved, and Brad seconded, that Lucy Kingsley be added to the Key Bank checking account for July 1999, to reimburse food vouchers.

The motion passed: 10 in favor and 0 opposed.

#### BUDGET - OdoT REPORT

Steve G reported that OdoT has informed the OCF that we will be required to move Maple Gate to create a longer deceleration lane. After negotiations OdoT agreed that the work could be done after the Fair in August or September. (Originally, they said it would have to be done pre-Fair.) This is good as we will be better able to afford the estimated \$25,000 expense when the bank accounts are at their fullest and the land will be dryer.

#### LANE ARTS COUNCIL MEMBERSHIP

Palmer moved, and Charlie seconded, that the OCF renew its membership with Lane Arts Council (\$130).

Peach Gallery: Martha Evans (Neighborhood Response Team/NRTs Coordinator)—The Lane Arts Council builds community as much as it supports the arts. One recent project was a joint 4-week workshop with Encore Theatre (a senior improv troupe) and the youth at Skipworth Juvenile Hall. It was a unique and amazing connection. Leslie said she had already mailed in the dues out of the GM's Miscellaneous budget because she believes the Lane Arts Council is vital to our community. However, the funding could be switched to the BoD's Membership budget. Norma added that she and Leslie wanted to nominate all Fair family as the super-volunteer

this year for the Lane Arts Council's Heart of the Arts awards. But, that was not permissible.

The motion passed: 10 in favor and 0 opposed.

#### OFFICE COMPLIANCE BUDGET

Jack moved, and Charlie seconded, that the Office Compliance Budget be increased by \$4,000 to finish the project.

Background: It is a long, complicated story. While the property for the in-town office is located in a mixed-use zone, no Certificate of Occupancy for the main floor of the building to be used as an office existed when it was purchased. Our permit application deadline, May 31, was met with George Braddock's help. The OCF needs to bring the whole building up to commercial fire code to obtain the Certificate of Occupancy. This includes fire suppression, ADA compliance, parking and systems development charges. \$10,000 was carried forward to the 1999 budget for this work. \$4,000 more will finish the project.

BoD: Jack: Speaking as a commercial developer, believes we are enhancing our property and protecting our tenants, equipment, staff, and investment.

The motion passed: 8 in favor and 2 opposed (Brad and Doug).

#### BYLAWS/SURVEY COMMITTEE REFERRAL

Palmer moved, and Dr. Jim seconded, that the motion approved at the October 98 Annual Meeting be sent to the Bylaws Committee to draft an amendment to institute the membership survey.

Peach Gallery: Thumbs up!

BoD: Brad and other members could hear Reese questioning why it took eight months to get this far! Dr. Jim noted that the Member Survey work session in December was meagerly attended. Charlie is unsure whether an amendment is necessary. However, Palmer noted, that this is what the membership voted and we've only had one response for committee membership.

The motion passed: 10 in favor and 0 opposed.

#### DRUG AND ALCOHOL FREE '99

Palmer moved, and Jack seconded, that the Fair adopt a policy for the 1999 Oregon Country Fair that it be a drug free Fair with alcohol consumption not allowed in public places.

Peach Gallery: Thumbs up!

BoD: Because this is already stated in the Guidelines, #9, this motion repeats what is already published. Palmer: This is a verbatim lift of the motions passed by the Board on 1/5/98 and 1/6/97. He prefers that the Board consciously restate the policy annually. Brad suggested that the motion should be made when the Guidelines are approved as a matter of good housekeeping.

The motion passed: 9 in favor and 1 abstention (Etienne).

#### HUBBARD PROPERTY

Charlie moved, and Marlene seconded, that the Board authorize the President, Jack Makarchek, to negotiate the purchase of the Hubbard property for approximately \$195,000.

Peach Gallery: Thumbs up!

BoD: Dr. Jim: At this point as there are minor glitches in the negotiations it will be more efficient to authorize Jack to proceed rather than calling a special BoD meeting each time there is a change. Palmer: The paperwork will be reviewed by the Fair's attorney and both realtors.

The motion passed: 10 in favor and 0 opposed.

#### REFER CREW CO-COORDINATOR APPOINTMENT

Tom moved and Charlie seconded that Steve Chase be appointed as the Refer Co-coordinator.

Peach Gallery: Steve said he has been working with Gary Kingery (Refer Co-coordinator) for the past five years and has been a Fair member for 20+ years. Gary: As of today, he is resigning his position and supports Steve. It's part of the natural process. Leslie thanked Gary for working hard to make the new site in front work well. Steve W. asked everyone to pray for high evaporation rates as the land where the big refer trucks sit is still wet and soft.

The motion passed: 10 in favor and 0 opposed.

#### **ECOLOGICAL STEWARDSHIP RESOLUTION**

Dr. Jim moved, and Charlie seconded, that it be resolved that the BoD of the Oregon Country Fair emphatically reaffirms the longstanding policy banning brush cutting and site clearing, a and be it further Resolved that the BoD specifically authorizes and directs the Site Manager to impose appropriate sanctions against violators of these guidelines.

Background: OCF has assumed stewardship of ecologically sensitive and fragile wetlands. Faithful stewardship of and respect for our land is one of the central tenets of the OCF philosophy. Underbrush, both live and dead, is an essential element in the complex and fragile ecology of our land. Brush cutting and site clearing are repeatedly prohibited in the Guidelines (Sections 29,

Peach Gallery: Steve W.: thumbs up! Lil: Mother Nature has already scrubbed clean much of the land this year. Others suggested coordinators educate Fair family and prevent, watch for and address such actions. VegManECs, the Site Manager and the Caretaker are all on-site to address questions/find solutions folks may have or need. Ann: Everything we do on site impacts the land. We are losing trees because of our actions. Martha Evans suggested more handouts and signs.

BoD: A healthy wetland can take an onslaught of most anything nature gives. As we cut and clear the understory, the ability of the rest of the fabric to hold up is diminished. Losingmore trees this year is a wake-up call. We might have to do wetlands mitigation. Be mindful of our actions. Marlene: We can educate folks so they want to comply and will educate their neighbors and family. Dr. Jim noted a lot of brush has been cleared already this year by humans. How is it possible for people to say, "I didn't know" if they have been part of the Fair for three years or more? Charlie: We are only on site for three days; the land is a living habitat. Brad: No nails in trees!

The motion passed: 10 in favor and 0 opposed.

#### ELDERS - SOPP

Brad moved, and Charlie seconded, the BoD create a Significant Older Person Pass (SOPP). The SOPP shall: 1) Be available for sale at the same rate as SOP passes. 2) Not count against the current SOP quotas in place. 3) Be purchased through the infrastructure in place, i.e., through crews or booths, etc. 4) Be available to any Fair member with a minimum of 20 years of Fair service, whose age is a minimum of 45, and whose age plus number of years of service to talks the magic number of 75.

Background: Join the discussion on-line: elderslistbot.com

Peach Gallery: The formula is not supposed to add up. (New Fair math: 45 + 20 = 75). Folks wondered how service would be validated. Reggie: One could produce a t-shirt for each year! Charlene: These numbers were adopted since many more young adults would soon be eligible for SOPPs under the old formula. Anne: Remember the resolution we just passed. Adding more folks impacts the land. There are still many operational issues that must be determined first. Steve W. agrees. We need to consider what this implies for the future. We could be doubling the number of folks on site in ten years. Just how many folks are/will be soon eligible: Reggie suggest a three-tier elder system: 1) working elder, 2) counseling elder (serves as mediator, etc.) and 3) retired elder. The last two would have higher age requirements. Leslie she hoped Brad wasn't suggesting that this take effect this year. Lil: We should survey the family at the Fair; coordinators could check their crews. The elders discussion should happen also during the Fair. Dennis Todd (LUMP) and others said they qualify but refuse to retire.

BoD: Palmer is concerned about the validation process and would like the Budget and Financial Planning Committee's input. Is there any Fair membership requirement? Dr. Jim: If we wait to figure out all the details we may well all be eligible. He would like to add a mentoring a young adult clause. It's a great first step. Brad said he continues to put the issue on the agenda so it won't fade away. Jack: This doesn't accomplish what is intended. We need to open the event and create some movement. Elders need to feelembraced and needed. Etienne supports holding an elders discussion on site this year end encourages more folks to join the dialogue.

Charlie moved, and Etienne seconded to table this item until

The motion to table passed: 9 in favor and 1 opposed (Michele).

Note: The following items died for lack of a presented: Donations to Fern Ridge Gleaners and Okanogan Highlands Bottling Company (it was decided that the latter request may be handled operationally at the GM's discretion). The Glass Free policy was actually adopted in '98 without any closure date so it remains in effect.

The following items were po: oned until the August meeting: Legal Fund, Purchasing Guidelines, and Board/member workshop. Arrow requested that the Bod consider Skirt Boards on Booths.

The next Bod meeting is scheduled for Saturday, July 3, 4 pm at the Youth Stage on site. The agenda, subject to change, includes OdoT Mitigation Ponds Acquisition, Hubbard Property Financing, and Donations to Misha Kassel and Friends of Oregon Midwives.
