Given the strong feelings surrounding this question, she had consulted the lawyer, the OLCC, and the insurance company, before deciding to make the purchase of alcohol, as had been past policy. Anne Henry noted that she did not like the idea of one person approving the purchase of alcohol. Marshall Landman suggested that next year, the Board of Directors approve the picnic committee to alleviate problems.

Folks suggested that the picnic be later in August next year. Some folks felt it was too close to the Fair. It was suggested that since this was somewhat of an evaluation item that we should discuss it at the evaluation meeting on August 30, 1987, 1:00 pm at Skinner's Butte Park.
