MINUTES

<u>Motion</u>: Steve moved to approve the minutes of the June 7, 1993 Board of Directors meeting. Anne seconded.

<u>Background</u>: Anne had a few corrections: (1) one hundred feedback forms for the 1992 Fair were received; (2) the representative of the Gathering of Nations who spoke was Jim Bossler; (3) in the wristband discussion she had said that B oard <u>and staff</u> were compassionate.

<u>Vote</u>: The motion passed 10 for, 0 opposed.

REPORTS

General Manager

Leslie Scott, GM, said advance ticket sales are going swimmingly (an apt choice of words given our recent weather). Speaking of the weather (the relentless rain. the unremitting rain. the wet rain. you call this a summer? Oh, sorry, where was I?) The excessive rain has caused us to lose 300 parking spaces so advertising is focusing on the merits of bus ridership. In fact, just to make it more attractive, the bus loading platform has been improved; three, count 'em 3, busses can unload at one time.

Plans for Zumwalt Park camping are going well.

Leslie feels we're ready to party. What do you say?

<u>Site Manager</u>

- 2. As of Friday, July 2, 9,100 tickets had been sold. Margo expects 5,000 to go. Quick. Hurry, go get 'em. Come on, now, you want to be there, don't you.
- 3. Margo reported that 14 kids have signed for rape awareness training, but there was not a large enough age group to schedule the trainings. Sexual Assault Support Services will do a safe touch puppet show at the Youth Stage every morning of the Fair at 10.
- 4. Anne apologized for the error in the <u>Peach Pit</u> which named Nance Sledge as Treasurer instead of Hilary Anthony. (hilary said no hard feelings, punched anne in the nose, and the whole thing was forgotten.)

OLD BUSINESS

FERN RIDGE LIBRARY

<u>Motion:</u> Bob moved to table the discussion about the Fern Ridge Library. Jeanne seconded. <u>Backgro</u>und: The Fern Ridge Library Planning Committee asked the OCF for a donation to help in its funding campaign.

<u>Board Comments</u>: Several Board members suggested to the Planning Committee that it submit its request to the Endowment Committee.

Vote: The motion passed, 10 for, 0 opposed.

TRAFFIC COORDINATOR

Moving right along....bad joke.

<u>Motion</u>: Steve G. moved that Hawk Owl deYoung be named Traffic Co-coordinator. Steve W. seconded.

Rain Contingency

<u>Board Discussion</u>: Anne thinks it's a great idea (the money, not the rain). Bob hopes we are not encouraging more overruns. (or else there won't be anything left for the secretary to run off to tahiti with. she hears the sun shines in tahiti.) <u>SECURITY</u>

Motion: Margo to approve expenditure of \$1,00 in food vouchers to keep the information booths staffed from 10 p.m to 6 a.m.. Jeanne seconded.

<u>Background</u>: Information booths will be staffed from 10 p.m. to 6 a.m. for the first time. <u>Board Discussion</u>: Anne said this suggestion was made in a feedback form received

after last year's Fair. Paxton would like to see booth staffing 24 hours a day next year.

<u>Vote</u>: The motion passed, 10 for, 0 opposed.

ALTERNATIVE PASS SYSTEM

Motion: Paxton moved to spend \$1,000 for 300 photo IDs. Bob seconded.

<u>Background</u>: This is probably going to come as a great shock but there are some people who do not want to wear wristbands. A photo ID is suggested for these folks. (Now that's being important.)

<u>Vote</u>: The motion passed, 9 for, 1 (Jeanne) abstained, 0 opposed.

PERSONNEL

<u>Motion</u>: Daniel moved to appoint Camille Cole, Leslie Scott, Doe, and Heidi Doscher to the Office Manager Hiring Committee. They would serve with the Personnel Committee: Daniel Dillon, Brad Lerch, and Martha Evans. Anne seconded.

<u>Background</u>: Sad to say Camille is leaving her position as Office Manager. Sob. <u>*Vote:*</u> The motion passed, 10 for, 0 opposed.

SAFETY

<u>Motion</u>: Margo moved to allow the Sexual Assault Support Services to use the OCF logo on sheets detailing safety information at the Fair. Steve W. seconded.

<u>Background</u>: Jill of SASS said safe booths will be identified as places for children to go if they feel they are in danger. When the occupants are present the booths will display signs identifying themselves as "safe booths".

<u>Board Discussion</u>: Anne asked that the signs be identifiable by children too young to read.

<u>*Vote*</u>: *The motion passed, 10 for, 0 opposed.*

1994 OREGON COUNTRY FAIR

Motion: Daniel moved that next year's Fair be July 8, 9, 10, 1994. Margo seconded.

<u>Public Discussion</u>: Robert Aurnague DeSpain suggested the Fair be held the next weekend. The earlier date is too soon after the Fourth of July and will lessen the time staff has to prepare for the Fair. Leslie would like to see the Fair put off to the next weekend; she feels we could use the extra time and separation from the Art in the Vineyards (a Eugene event). (the secretary wonders why they don't just move independence day. the fair is much more important than any old national holiday.)

<u>Board Discussion</u>: Anne pointed out that the weekend of July 15, 16, 17 is the same weekend as the Salem Art Fair and the Vancouver Folk Festival. This could cause a conflict for vendors and entertainers.

<u>Vote</u>: The motion failed, 4 for, 6 (Margo, Kelly, Daniel, Steve W., Jeanne, Jack) opposed.

<u>Motion</u>: Jeanne moved to have the next Oregon Country Fair the weekend of July 15, 16, 17, 1994. Margo seconded.,

<u>*Vote*</u>: *The motion passed 7 for, 3 opposed (Bob, Paxton, Anne).* NEXT MEETING
